INSTRUCTIONS

(1) Which Creditors Do You List?

- A. <u>Every Debt</u>. Provide information on <u>every</u> debt including leases and rent-to-own contracts.
- B. "<u>Maybe</u>" <u>Debts.</u> Provide information on creditors that *might* say you owe them money *even if* you believe or know they are wrong, and you don't really owe them money.
- C. <u>Debts You Want to Keep</u>. Provide information on debts you want to keep.
- D. NonDischargeable Debts. Provide information on debts you do not think will go away (be discharged)

(2) How Do You List A Debt?

A. <u>Complete</u> one section below for <u>every</u> debt. (Yes, we can get you more, if needed.)

B. <u>Last 90 days</u>. Please make special note of any part of a debt you incurred in the last 90 days. Some debts incurred just before filing are NonDischargeable, i./e., will not "go away" with the filing of the bankruptcy. Examples include credit card usage in the 90 days before this form is filled out.

(3) <u>What Documents Do You Provide?</u> Please provide the following:

- A. <u>Most Recent Billing Statement or Letter</u>. Provide this for every debt where you have a statement or letter.
- B. Lawsuit Documents. If you have been sued on a debt, please provide any documents you have.
- C. Garnishment Documents. If you have been garnished, please provide the documents you have
- D. Foreclosure Documents. If a foreclosure is threatened, please provide the documents you have

NOTICE: Giving us your creditor report and/or copies of bills is NOT enough. That does not give us all the information we need. To help you properly, You MUST also fill out a section for every debt.

(4) <u>We Can Help</u>. For \$30 (one person) or \$58 (spouses), we can help you provide this information by accessing the information on your credit report. This service can help you avoid having to fill out these forms by hand for the debts found on your credit report. [Note: This is not the fee to get a credit report. You can get a free credit report each year from <u>www.AnnualCreditReport.com</u>. KreditKarma.com might also be helpful.]
